Dear Parents/Guardians,

As we continue to prioritise the safety and well-being of all our students, I would like to kindly remind you of a few important safety matters. Lack of supervision is causing us some safety concerns and we have experienced damage to our allotments / polytunnel.

Supervision After School:

Please ensure that your children remain with you at all times once they are collected at the end of the school day. We have observed some children climbing or using the banks around the school as pathways, which are not intended for play and pose potential safety risks. Some young children have been left unattended on the main steps- this could be dangerous. If you are collecting additional children, we kindly ask that all children remain under your supervision while waiting to ensure a safe and orderly environment. We would like to kindly remind you that it is your responsibility to supervise your child once collected from school, even if they are still on the school grounds.

Breakfast Club Safety:

Additionally, it has come to our attention that some parents are leaving their children in the car park, assuming they will enter the school on their own. For the safety of your children, particularly those in **Year 4 or below**, each child must be walked to the Breakfast Club door and safely handed over to staff. This ensures that all children arrive safely and securely into the school building. If your child did not enter through the door and wandered off they would be classed as missing. Parents should not assume that their children have arrived safely unless they have seen them.

Car Park Safety:

Please remember that the car park is **not a safe place to play**. The gates remain open, and children left unattended in this area could wander/ run out onto the road, placing them in serious danger. Children should always be closely supervised while in the car park.

Car Park Use for Blue Badge Holders:

Blue badges MUST be displayed at all times when using the car park.

We have also noticed that some parents are using the car park to drop off or collect children. Please be aware that the car park is **only for use by those who hold a Blue Badge**. The parents driving in without a blue badge and turning around is creating an unsafe environment. **Only use the car park / disabled bays if you are a blue badge holder.**

School Reception Area

Unfortunately we are unable to offer seating in the school reception area at morning and afternoon pick up times this is due to confidentiality of phone calls / meetings that take place in the office.

We appreciate your understanding and cooperation in these matters. Our shared goal is to maintain a safe environment for every student, both at the start and end of the school day.

Wrth i ni barhau i flaenoriaethu diogelwch a lles ein holl fyfyrwyr, hoffwn eich atgoffa'n garedig am ychydig o faterion diogelwch pwysig. Mae diffyg goruchwyliaeth yn achosi rhai pryderon diogelwch i ni ac rydym wedi profi difrod i'n rhandroedd / polytunnel.

Goruchwyliau ar ôl ysgol:

Sicrhewch fod eich plant yn aros gyda chi bob amser unwaith y byddant yn cael eu casglu ar ddiwedd y diwrnod ysgol. Rydym wedi gweld rhai plant yn dringo neu'n defnyddio'r glannau o amgylch yr ysgol fel llwybrau, nad ydynt wedi'u bwriadu ar gyfer chwarae ac sy'n peri risg diogelwch. Mae rhai plant ifanc wedi cael eu gadael heb oruchwyliaeth ar y prif risiau - gallai hyn fod yn beryglus. Os ydych chi'n casglu plant ychwanegol, gofynnwn yn garedig i bob plentyn aros o dan eich goruchwyliaeth wrth aros i sicrhau amgylchedd diogel a threfnus. Hoffem eich hatgoffa'n garedig mai eich cyfrifoldeb chi yw goruchwyliau eich plentyn ar ôl ei gasglu o'r ysgol, hyd yn oed os ydynt yn dal i fod ar dir yr ysgol.

Diogelwch Clwb Brecwast:

RHAID arddangos bathodynnau glas bob amser wrth ddefnyddio'r maes parcio.

Rydym hefyd wedi sylwi bod rhai rhieni yn defnyddio'r maes parcio i ollwng neu gasglu plant. Byddwch yn ymwybodol bod y maes parcio i'w ddefnyddio gan y rhai sydd â Bathodyn Glas yn unig. Mae'r rhieni sy'n gyrru i mewn heb fathodyn glas yn creu amgylchedd annioedd.

Defnyddiwr y maes parcio / llefydd anabl dim ond os ydych yn ddeiliad bathodyn glas.
